**THE FILMS AND STAGE PLAYS (CINEMATOGRAPH FILMS)
(FORMS AND FEES) (AMENDMENT) REGULATIONS, 2023**

IN EXERCISE of the powers conferred by section 35 (1) of the Films and Stage Plays Act, the Cabinet Secretary makes the following Regulations—

**THE FILMS AND STAGE PLAYS (CINEMATOGRAPH FILMS)
(FORMS AND FEES) (AMENDMENT) REGULATIONS, 2023**

Citation. 1. These Regulations may be cited as the Films and Stage Plays (Cinematograph Films) (Forms and Fees) (Amendment) Regulations, 2023

Sub. Leg. 2. The Films and Stage Plays (Cinematograph Films) (Forms and Fees) Regulations are amended by inserting the following new regulation immediately after regulation 1—

Application of these Regulations **1A.** These Regulations shall apply to fees payable in respect of applications for filming licences and registration of film agents.

3. The Principal Regulations are amended by inserting the following new Regulations after Regulation 5

Certificate of Registration of Film Agents **5A.(1)** There shall be a requirement for the registration of film agents and a certificate issued for the facilitation of foreign film makers, who for the purpose of these Regulations, is a film maker who is not a Kenyan citizen.

(2) The application for the registration of film agents shall be in accordance with the prescribed form and at a prescribed fee.

(3) The certificate of registration of film agents shall be for a period of one year from the date of issue.

(4) Upon renewal of the certificate, the film agent shall be required to file returns as

prescribed.
